During the Srinagar-Jammu train journey on September 25, 1992, a cold case from Indore was moved to Jammu. Two boys, aged 16 and 17, were caught between the wheels of the Express train and were run over. There was only one eyewitness to the accident. The Railway Police recorded the incident as a "unintentional death" and closed the case. The boys' families did not pursue the case, and the local

police authorities were not interested in giving the boys a proper burial and, consequently, the bodies were buried in the graveyard at the Indian Institute of Technology (IIT) under Buttala, where many of the locals worked. Some years later the local police mentioned the incident in their papers, but no action was ever taken. The story was picked up by the media and the father of the boys decided to bring the matter to the notice of the Railways, which did not respond. In November 2011, the issue came to the attention of the present Railway Minister, Pawan Kumar Bansal, who was the Minister of State for Railway at that time. In his letter dated December 2, 2011 to the Railway Board chairman, he stated that he had ordered a special investigation on the accident. However, the government of that state ignored the investigation and the matter was deferred. In January 2013, the Railway Minister Bansal visited the spot and the in-charge of the minister of state for rail, Suresh Angadi, was handed over the matter by the minister. There were some flaws in the investigation by the local police, which pointed to a cover-up. For example, the railway police's investigation showed the boys were traveling from Jammu to Srinagar for a long vacation, not returning to Indore, where they boarded the train for the return journey to Jammu. Thus, the two boys had alibis when the accident happened. These facts were clearly mentioned in the report. The victim's uncle, R.K. Mishra, lodged a complaint at the Jammu police station, where it was rejected by a police official on the grounds that there was no eyewitness or any credible witnesses. The present Railway Minister's letter of August 3, 2013 shows that he has not been satisfied with the police inquiry. He has called for a special investigation by a team of railway experts headed by the state government's police commissioner in Jammu. The case was assigned to the Regional Transport Officer (R
